Regulatory Examination (RE) Training

Representatives and Key Individuals who must write the Regulatory Examination for Key Individuals (RE1) or Representatives (RE5) can benefit from this training. We have Virtual Instructor-led Training (VILT) as well as online training programmes on our eLearning platform, available for RE1 and RE5. Content as published in Board Notice 194 of 2017, with updates, is covered in the workshop. Proven study methods and techniques are demonstrated.

The Regulatory Examinations are notorious for being tricky – we know there are tons of terms and concepts which one has to master in order to pass the exam. Let us help you to succeed!

Requirements*: For the **ONLINE** Regulatory Examination training on the eLearning platform, you need access to a computer as well as a reliable internet connection.

RE5 Zoom Workshop

Combined RE5/RE1 Training

RE5/RE1 Zoom Bootcamp

Since a great deal of the content overlaps, the RE5 and RE1 training can be delivered as a combined course. The RE1 content that is not covered in RE5, will be covered in the morning of day 3 of the RE Zoom Workshop.

Online RE5/RE1

If you register for both the RE5 and RE1 online study programmes, the programmes are offered at a discounted fee. (*Refer to the requirements for the online training in the first column.)

Online Regulatory Examination Preparation Pack (Stand Alone eLearning Programme)

If you need help understanding what is expected from you in the exam, you can register for this training. The programme is focused on exam preparation and is specifically designed for those learners who find it difficult to analyse the exam questions. Before you register for the Exam Preparation Training, you must ensure that you know and understand the FAIS Act and other applicable legislation.

When you register for any of the Zoom workshops, or the RE5 and/or RE1 online training, you also get complimentary access to the eLearning Regulatory Examination Preparation Pack.
